DESCRIPTION of PROGRAMS

Emergency Medical Technician (EMT)

Program Objective: The EMT program prepares students with the knowledge, skills, and abilities required to perform emergency medical services and qualify to sit for the National Registry of Emergency Medical Technicians (NREMT) examination.

Total Program Hours: 170 Clock Hours (Classroom Instruction, Quizzes, In-Person Skills Practice, Final Exam, and Skills Evaluation) plus **24 hours of in-field observation (ambulance ride-along).**

Instructional Method: In-Person with supervised field training.

Program Length: Up to 12 Weeks (All

program components must be completed within 364 days of enrollment agreement signature).

Units: Certificate of Completion.

Occupational Outcomes: Graduates may qualify for employment as Emergency Medical Technicians in ambulance services, fire departments, hospitals, and related emergency response settings.

Licensure Disclosure: Completion of this program is designed to meet the educational requirements for EMT certification in California. Certification and employment requirements vary by state. Fire Future Training Institute makes no guarantee of licensure or employment.

*Any student who turns in falsified documentation and/or clinical hour form will be disqualified and fail the course. The student will not be eligible to enroll in future courses. Policy on Involuntary Separation.

Psychomotor Exam Only

Program Objective: This exam fulfills all state and National Registry Emergency Medical Technician (NREMT) skills requirements. The exam will take approximately one hour to complete.

Prerequisites: The student must be 18 years of age or older at the time of registration and have a valid EMT license or letter to test from NREMT.

***At the time of enrollment, proof of EMT license or letter to test from NREMT must be provided.**

Classroom Training: Psychomotor exams are held on the 1st and 3rd Saturday of every month, and students must register with their instructor in advance to be placed in a psychomotor exam session. Students must successfully perform all items on the skills sheet.

Required EMT Psychomotor Skills Verification Training Session (8 Hour EMS-CE) (Training EMTs on Skills Verification/Testing) This training session is intended to help you prepare for EMT Skills Verification. It is a full day of training that focuses on the necessary steps to perform your skills in a testing format.

24 Hours of Emergency Medical Technician (EMT) Continuing Education

Objective: A comprehensive and active review of the new Education Standards, providing both an overview of new information contained within the Education Standards at the EMT level and a source of continuing education. The 24-hour course includes the following topics: preparatory - 1 hour, airway - 2 hours, patient assessment - 3 hours, OB/infants/children - 2 hours, trauma - 4 hours, medical/behavioral - 4 hours, elective - 8 hours.

Prerequisites: Students must be 18 years of age or older at the time of registration and

have a valid EMT license. At the time of enrollment, proof of the EMT license must be provided.

Classroom Training: Includes classroom and skills training and a final exam. Class days, hours, and lunch breaks are announced on the first day of class. Students must receive 80% or better on the final exam before the EMT course certificate is issued.

(24 Hours is required to complete the 24 Hrs. EMT Continuing Education.)

Basic Life Support CPR (BLS CPR)

Objective: The course is designed to certify students in basic life support CPR based on the American Heart Association 2025 protocols.

Prerequisites: The student must be 18 years of age or older at the time of registration.

Classroom Training: Four (4) hours, which includes skills and classroom training and a final exam. The student must receive 80% or better on the written exam and pass skills testing.

CANCELLATION, WITHDRAWAL, and REFUND POLICY

Student's Right to Cancel: Students have the right to cancel/withdraw from any Fire Future LLC. Education Program. Cancellation and/or withdrawal notice must be in writing. Written notification is to be emailed to: admin@firefuture.com. Cancellation/Withdrawal can be effected by the student's conduct, including, but not necessarily limited to, a student's lack of attendance or the student's written cancellation notice.

Refund Policy shall apply to the above notification, classes listed below, in accordance with the student's attendance, and pro-rated as depicted in each class category below.

Please contact Fire Future LLC, via formal written email at admin@firefuture.com, to request a refund. In your email, include the student's name, date of enrollment, and reason for requesting a refund. The student's email request shall be reviewed, and results (of refund approval or non-approval) will be communicated to the student within 30 days of receipt of notification. If a refund is the final decision, a check will be issued within 45 days of receipt of withdrawal or cancellation notice. If a student received federal student financial aid funds, the student will be entitled to a refund of monies not paid from federal student financial aid program funds. An explanation that the student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later, the position or positions to whom the notice to cancel/withdraw must be delivered to:

days or hours in the program), multiplied by
the number of days student attended, or was
scheduled to attend, prior to withdrawal.

A student who has completed 60% or less of the period of attendance will be issued a pro-rata refund as follows: A student who cancels within 30% of class will be refunded 75% of tuition less the non-refundable registration fee. A student who cancels with 60% of class completed will be refunded 50% of tuition less the non-refundable registration fee. A student who has completed more than 60% of class will not receive a refund.

* Policy on Involuntary Separation:

Adherence to the Student Code of Conduct is a condition of enrollment.

ENROLLMENT REQUIREMENTS

Students must be at least 18 years of age or older at the time of registration for all courses. Students must provide proof of high school diploma, GED, or passage of the California high school proficiency exam for Emergency Medical Technician –Basic (EMT-B) Classroom. Students must provide a copy of Basic Life Support CPR card for Emergency Medical Technician –Basic (EMT-B-I) Classroom courses. Students must provide a copy of EMT License or letter to test from NREMT for Emergency Medical Technician –Refresher, Psychomotor Exam Only, 24 Hours of EMT Continuing Education. Students must provide a copy of EMT or Paramedic License for Medical Unit Leader S-359 (MEDL) course.

DISCIPLINARY PROBATION POLICIES

Students may be placed on probation on disciplinary grounds at the discretion of the Program Director. Grounds for disciplinary probation include, but are not limited to, failed compliance with:

1. The standards of ethics, professional behavior, and conduct set forth in this manual.
2. Attendance policy.
3. Dress codes during classroom / Ride-along phase of training.
4. Rules of classroom.

DISMISSAL POLICIES/ INVOLUNTARY SEPARATION

Adherence to the Student Code of Conduct is a condition of enrollment.

Any student found violating any of the following will be immediately removed from the course:

1. Cheating on ANY exam(s) and/or quiz, assessments
2. Inappropriate behavior (sexual harassment, violence, intoxication, drug use, etc.) in the classroom or during ride-along.
3. Turning in falsified documentation and/or clinical hours on the ride-along forms
4. Violation of attendance policies
5. Violation of academic policies
6. 60% or more of the program has been completed and a refund will not be issued.

APPEAL OF DISCIPLINARY TERMINATION / GRIEVANCE

If a student is terminated on disciplinary grounds, he or she can file an appeal of the decision of the grievance by filing a written appeal with the Program Director at Fire Future LLC. The appeal must be filed within (2) two days of the effective date of the termination. It must include an explanation of the circumstances of the termination, and specific and detailed reasons why the student believes the termination was unjustified. The student may also submit any relevant witness statements. An appeal lacking this information will be summarily denied without further action. The Program Director will review the appeal and take any action reasonably necessary to reach a decision, including interviewing the student and any relevant witnesses. The Program Director will issue a decision on the appeal within 7 days of the date it is filed. The decision will be final and binding.

If a student has a grievance regarding any component of their time as a Fire Future LLC.

Student, they may contact their immediate instructor and/or the Program Director. Fire Future LLC. recommends filing the appeal and complaint with the Program Director; however, you may file a complaint with the Bureau for Private Postsecondary Education at any time. STUDENT TUITION RECOVERY FUND (STRF)

“The State of California established the Student Tuition Recovery Fund (STRF). *Student Tuition Recovery Fund - Students enrolled at the time of school closure (or within 120 days of the school's closure) may be eligible for reimbursement through the Student Tuition Recovery Fund (STRF). The STRF exists to relieve or mitigate economic losses suffered by a student in an educational program at a qualifying institution if the student was a California resident (or was enrolled in a residency program).*” Application for STRF can be obtained from:

“This catalog includes programs that are approved by the California Bureau for Private Postsecondary Education and subject to the California Private Postsecondary Education Act of 2009 and others that are not. Certain rights and protections outlined in this catalog, including but not limited to student refund rights, cancellation rights, and Student Tuition Recovery Fund (STRF) eligibility, apply only to the following state-approved programs:”.

“The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment if you are not a California resident or are not enrolled in a residency program.”

(b) In addition to the statement required under subdivision (a) of this section, a qualifying institution shall include the following statement in its school catalog:

“It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. To be eligible for STRF, you must be a California resident or enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
2. You were enrolled at an institution or a location of the institution within the 120-day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120-day period before the program was discontinued.
3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of non-collection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a Social Security number or a taxpayer identification number.”

The STRF is a fund administered by the Bureau for Private Postsecondary Education (Bureau) that relieves or mitigates economic loss suffered by a student while enrolled in a qualifying

institution - generally, one that is approved or registered by the Bureau. At the time of his or her enrollment, the student must have been a California resident or enrolled in a California residency program, prepaid tuition, and suffered economic loss.

Effective April 1, 2024, the Student Tuition Recovery Fund (STRF) assessment rate will change from two dollars and fifty cents (\$2.50) per one thousand dollars (\$1,000) of institutional charges to zero dollars (\$0.00) per one thousand dollars (\$1,000) of institutional charges. (5, CCR section 76120). Institutions will still be required to complete and submit all STRF Assessment Reporting Forms on a quarterly basis and maintain specified student information for STRF-eligible students.

Institutions approved or registered with the Bureau are required to comply with the following STRF requirements:

- Include STRF disclosures on both its enrollment agreement and school catalog (5 CCR Section 76215)
- Collect STRF assessments (if applicable) from each student in an educational program who is a California resident or is enrolled in a residency program (5, CCR section 76120)
- Collect the STRF assessment from each student in an educational program at the time it collects the first payment from or on behalf of the student at or after enrollment (5, CCR section 76130)
- Complete and submit quarterly STRF Assessment Reporting Form and remit payment (if applicable) to the Bureau no later than the last day of the month following the close of the quarter (5 CCR section 76130).

Students Rights and Responsibility -

The Student Tuition Recovery Fund (STRF), as described in California Code of Regulations (CCR) §76215, is a state-administered fund to help California residents who have suffered economic loss from a qualifying private postsecondary institution. Students may be eligible for relief if they prepaid tuition and the institution closed, failed to pay a refund, failed to pay loan proceeds, or failed to meet quality standards, among other reasons. To be eligible, students must have been a California resident or in a residency program at the time of enrollment, prepaid tuition, and paid the state-imposed assessment.

Who it's for

- Students: Primarily for California residents enrolled in California residency programs who prepaid tuition.
- Qualifying Institutions: Private postsecondary institutions approved or registered by the California Bureau for Private Postsecondary Education (BPPE).

How to qualify

- Be a California resident or enrolled in a California residency program.
- Prepay all or part of your tuition.
- Have suffered economic loss due to the institution's actions, such as:
 - The school closed unexpectedly.
 - The school failed to pay refunds or other charges.
 - The school failed to pay or reimburse loan proceeds.
 - There was a significant decline in the quality of the educational program.
- Not have had all your charges paid by a third party.

Important to know

- Assessment: Students must have paid the state-imposed STRF assessment, though the current rate is \$0.00 per \$1,000 of institutional charges as of April 1, 2024.
- Time limit: Applications must be received within four years of the event that made the student eligible.
- Application process: You can apply online through the BPPE's Student Tuition Recovery Fund Portal or by submitting a paper application.
- Documentation: You must provide supporting documents for your claim, such as enrollment agreements, proof of payment (receipts, canceled checks, bank statements), and loan documents.

ATTENDANCE POLICY

In order to be successful, students should make every effort to physically (meaning face-to-face) attend each classroom session. The following is the Attendance Policy for each program:

Emergency Medical Technician (EMT)—Basic EMT-B-I Classroom Version:

Students may miss no more than 10 hours of classroom time. Students are required to notify the instructor at least one hour in advance prior to class start time. This notification MUST be via text **and** email. The student will be assigned “make-up” work to complete what was missed and it MUST be submitted to the instructor by the next class date. Attendance is mandatory on class dates that include skills testing, ride-along, and final exam. 60% or more of the program has been completed and a refund will not be issued. Failure to attend on those dates is grounds for immediate dismissal from the course WITHOUT refund. Extended “Leaves of Absence” are not permitted.

Emergency Medical Technician—Refresher

Students MUST be present at ALL classroom times to complete this course. No absences are permitted.

Psychomotor Exam Only

Exam date must be scheduled between Instructor (or) Director and student. Rescheduling must be communicated to instructor via email at least 24 hours in advance.

24 Hours of EMT Continuing Education

Student MUST be present at ALL classroom times to complete this course. No absences are permitted.

LEAVE OF ABSENCE POLICY

Due to the structure of course material, no leaves of absence are permitted.

STUDENT ACHIEVEMENT STANDARDS

1. Course Participation

Attendance and participation are essential for EMT education and training. Attendance is mandatory. Please refer to your class syllabus.

2. Skills Participation

In order to gain proficiency in the skills of an EMT, students must practice. The skills participation is based upon successful completion of the Skills

A series of 10 quizzes will be given on a regularly scheduled basis. They are multiple-choice

and vary in length. All exams will be taken on the scheduled session.

3. Final Examinations

The final exam will be given at the end of the Program and include all subject areas from the entire program. The exam will be multiple choice .

All skills exams are counted as Pass / Fail items and must be successfully completed.

Student must achieve 80 % of the possible points and no critical criteria failures. In addition, 24-hours of clinical observation with a minimum of 10 patient contacts must be completed. Along with these items, a professional behavior evaluation, successfully completed by the faculty, assessing your competence in the affective domain must be documented.

4. NO ELECTRONIC DEVICES ARE ALLOWED DURING TESTING. JOB OPPORTUNITIES

This course is designed to prepare students to work as an Emergency Medical Technician (EMT) in the EMT field in various positions (US DOL SOC 29-2041). The following prerequisites must be met in order to apply for EMT licensure and:

1. Must be at least 18 years old.
2. Immunizations must be current and up-to-date.
3. Must pass a criminal background check.
4. Must pass the NREMT certification exam.

ELIGIBILITY LICENSING / REQUIREMENTS

What are the requirements to become an EMT in California?

To become an EMT in the State of California, you must: To become an Emergency Medical Technician (EMT) in California, you must meet several requirements and complete a multi-step process.

General Prerequisites

Before beginning the certification process, you generally must:

- Be at least 18 years old.
- Have a high school diploma or GED.

- Possess a valid government-issued photo ID (a California driver's license is often required by employers).
- Hold a current Basic Life Support (BLS) / CPR certification for Healthcare Providers from a recognized organization (e.g., American Heart Association or American Red Cross).
- Meet physical fitness and health clearance requirements, including necessary immunizations (e.g., Hepatitis B, MMR, Tdap, TB screening).
- Your NREMT certification card.
- Your current CPR/BLS card.
- A completed Live Scan background check for state and federal criminal history reports. (A clean background is necessary for certification).
- Payment of all required fees.

Certification Steps

The certification process involves three main steps:

- Complete a State-Approved EMT Training Program: You must successfully complete a minimum of 170 hours of training from a California-approved program. This includes classroom instruction, skills labs, and mandatory clinical experience (e.g., hospital and ambulance ride-alongs).
- Pass the National Registry of EMTs (NREMT) Exam: After finishing your training, you must pass both the cognitive (written) and psychomotor (skills) portions of the NREMT exam. Passing the NREMT exam qualifies you for state certification.
- Apply for California Certification at a Local EMS Agency (LEMSA): California delegates the final certification to local agencies. You must apply to the LEMSA in the county where you plan to work or reside. This application typically requires:
 - Proof of successful course completion (within the past two years).

Once your application is approved and the background check is clear, the local agency will issue your California EMT card, and you will be assigned an EMT number in the State Central Registry. You cannot work as an EMT in California until this entire process is complete.

- Successfully complete an approved EMT training program.
- After completing your training, you must pass the National Registry (NREMT) cognitive and psychomotor examinations.
- Apply for certification at a local EMS agency.

This educational program is designed to prepare graduates for positions in the State of California EMT Emergency Medical Technician field, which requires licensure by the State of California.
